<u>Motion: Gramlich 2<sup>nd</sup> Liedel</u> to approve the reading of June 10<sup>th</sup>, 2009 minutes. Carried.
<u>Motion: VanAuker 2<sup>nd</sup> Liedel</u> to pay bills as presented. Carried.
<u>Treasures Report:</u> Accepted as printed.

Items from the floor: No public comment.

## **Old Business**

**Sewer Project:** The sewer project for the sanitary manholes has been advertised and the Village of Maybee will be accepting bids at the office of Mannik & Smith Group until 10:00 a.m., on Monday, July 20, 2009.

<u>Sidewalk Repairs</u>: Council again discussed the issue of sidewalk repairs and President Gaylor is checking into pricing with various contractors for the needed repairs to be done.

**<u>Planning Commission</u>**: The Village is looking for a few more members to be on the planning commission board as 5 members are needed in all. Rick Smith & Matt Gramlich were 2 people suggested by council at tonight's meeting to serve on the board.

**Election Report:** All of the necessary paperwork has now been filed with the Monroe County Election Clerk and also a motion was made on the amount of \$100.00 dollars to pay the appointed inspectors for the upcoming election to be held on September 15<sup>th</sup>, 2009. **Motion: Liedel 2<sup>nd</sup> VanAuker** to set the amount at \$100.00 dollars to pay each appointed inspector for the election on September 15<sup>th</sup>, 2009. Carried.

## New Business

**Highway Fund - Budget Item:** The issue of amending the budget to increase the amount for contracted services under routine maintenance in the highway fund was discussed by council. A motion was then made by council to increase contracted services to \$7,000.00 dollars. **Motion: Gramlich 2<sup>nd</sup> Liedel** to amend the budget for contracted services in the highway

account to \$7,000.00 dollars. Carried.

<u>3 Way Stop</u>: The issue of converting the intersection of Bluebush Road and Raisin Street into a three way stop due to the increased amount of traffic and speed at which the vehicles travel was discussed. All were in agreement on this issue. A motion was needed to proceed with the issue and was then made.

**Motion: Gramlich 2<sup>nd</sup> VanAuker** to proceed with getting a 3 way stop on the above named intersection with both a traffic signal and signs and not to exceed the amount of \$7,000.00 dollars for the total costs involved. Carried.

**Building Inspector:** Dave Friend is no longer the building inspector for Exeter Township however, he will remain the inspector for the Village of Maybee. If anyone is in need of obtaining a permit contact the village hall with your information and we will make sure that Dave receives it.

<u>Water District</u>: There has been no change regarding this issue. Everything for now is being left as it was discussed in last months meeting.

<u>Motion: Gramlich 2<sup>nd</sup> VanAuker</u> to adjourn the meeting at 8:20 p.m.. Carried. <u>Next Meeting:</u> August 12<sup>th</sup>, 2009.
