**Library Approval:** Earlier in our meeting council members were informed of the many services that the Monroe County Library provides for citizens. A motion was then made to approve our portion towards the renewal of the millage that helps fund the library's operating budget.

**Cameras at Concession Stand:** Council members were informed that the Maybee Day Committee has generously paid for the cameras that have been installed down at Maybee Park at the Concession Stand. Thank You to the members of the Maybee Day Committee.

**Road Repair Of Baldwin At RR:** President Gaylor is checking pricing with Cadillac Asphalt Company to repair the damages done by the railroad's equipment while working on the project. This issue will be discussed at the next council meeting.
