who was recommended by the village attorney to be the hearing officer for this new ordinance if it should go into effect. A motion was then needed for this issue.

**Motion: Gramlich 2<sup>nd</sup> Lieto:** to appoint Paul De Lisle to be the Dangerous Building Hearing Officer for the Village of Maybee should this ordinance become effective. Carried.

**Motion: Lieto 2<sup>nd</sup> Gramlich:** to adjourn the meeting at 8:20 p.m.. Carried.
