Old Business:

Veteran and First Responder Memorial in Park: President Gramlich met with Mr. Borbely to sign more paperwork for the project. Fundraising has also begun for the project.

<u>Recreation Committee Report</u>: Lisa Gramlich reports that there are 27 kids registered for soccer and 12 registered for flag football. Mrs. Gramlich also asked the council for their support for the Recreation Committee to apply for a grant offered by the Monroe County Foundation. The grant is available for use to make public parks more accessible; the hope is that our park would be more accessible by installing handicap-friendly swing sets as well as paving paths through the park.

<u>Street Administrator Report:</u> President Gramlich reports that Marvin Iott has filled some potholes around the Village.

Baldwin Road Update: No update, the project is still expected to be finished in 2022.

New Business

<u>Reverend James Puhl:</u> Reverend Puhl took the floor to introduce himself as the newly appointed Pastor at Saint Paul's Lutheran Church on High St. Reverend Puhl expressed his enthusiasm to be a part of the community and encouraged the council and residents to reach out with any questions. The Village wishes Reverend Puhl a warm welcome.

<u>Andrea Keene With The Candle Shop:</u> Mrs. Keene took the floor to introduce herself and her new candle business, The Candle Shop, located at 7769 Bluebush Rd. Mrs. Keene said the grand opening will be on Maybee Day, May 7th. The Village also wishes Mrs. Keene and her business a warm welcome.

<u>Bi-Yearly Village Audit:</u> The bi-yearly audit done on the Village was recently finished, it was a success and the Village accounts are in good standing.

<u>Beautification Committee:</u> There wasn't any new interest in forming a committee at the meeting. There was discussion on things around the Village that could use sprucing up such as flower baskets, flower planters, and lights at Christmas.

The Village is also interested in hiring an hourly worker to help tend to some landscaping and other jobs.

<u>Council Comments:</u> Council Shaw thanks Lisa Gramlich and the rest of the Recreation Board for their work and dedication to expanding the Recreation program. Council Shaw also mentioned that volunteers are appreciated and welcomed to run the concession stand during seasons.

Public Comments: A resident asked who is responsible for sidewalks within the Village. President Gramlich stated that the Village takes care of sidewalks, but 40% of the expense is the homeowner's responsibility and 60% of the Village's responsibility. A resident brought up a couple of homes in the Village that may be in violation of ordinances. The Village will follow up with the Village Ordinance Officer.
