Absent: Council Lieto, Gramlich, & Treasurer Grubb. <u>Motion: Liedel 2<sup>nd</sup> VanAuker</u> to approve the reading of April 9<sup>th</sup>, 2008 minutes. Carried. <u>Motion: Weyher 2<sup>nd</sup> Younglove</u> to pay bills as presented. Carried <u>Treasures Report:</u> Accepted as printed.

Items from the floor: No public comment.

## **Old Business**

<u>**Tree Service:**</u> Woodchuck tree service has been trimming and removing trees throughout the village and the residents are very pleased with the fine job they are doing.

**Parking Behind Bank:** A lease has been drawn up for the village to use the bank parking lot for a municipal parking area. A motion was then made.

<u>Motion: Liedel  $2^{nd}$  Weyher</u> to accept the lease agreement and signed by President Gaylor. Carried.

**Sidewalk Repair:** After much discussion about repairing & replacing sidewalks and the pricing involved both to the village and the residents, council decided to table the issue. Further discussion will take place at the next council meeting.

**Basketball Court Installation:** The new basketball court has now been installed down at Maybee Park. Thank you to council Younglove and Liedel for helping improve our park.

**Baseball Diamonds:** We are working to improve the conditions of the outfields at Maybee Park. More information will be made available from Larry Gramlich at the next meeting.

**Fence Installation:** New fencing has been put in at the tennis and basketball area of Maybee Park and the job is now completed.

## New Business

**Library:** The Village of Maybee received a letter from The Maybee Library Advisory Board asking the village how to handle the refund check. After discussing the issue a motion was made.

**Motion: Liedel 2<sup>nd</sup> VanAuker** to put the funds into a contingency fund. Carried.

**Budget Amendments:** There were a couple of amendments that were made to the budget. The first one being to amend the auditing fees from \$10,000 dollars to \$11,500 dollars. The second was for insurance & bonds for the village from \$6,000 dollars to \$12,000 dollars, A motion was then made.

Motion: Liedel 2<sup>nd</sup> Younglove to amend the budget as stated above. Carried.

**Storm Drains:** President Gaylor addressed council and said that the storm drains were in need of being cleaned in the village and that Mark Liedel would be bringing in a truck to help with the job. Dale Younglove and Cliff Weyher offered to help Mark. Council then made a motion.

Motion: Weyher 2<sup>nd</sup> VanAuker to have the storm drains cleaned in the village. Carried.
