<u>Acknowledgement of Outgoing Clerk:</u> Clerk Theresa Gross was acknowledged for her 10 years of service to the Village of Maybee. She was presented a plaque and a gift from the President and the Council.

Motion: Archer 2nd Liedel to approve the agenda for tonight's meeting. Carried.

<u>Building Next Door (9043 Raisin)</u> Interest was expressed in contacting Oerther and looking into grants for rehabilitation of the deteriorating building rather than it being torn down. The building could be used for meetings or holding equipment.

<u>Purchase of Christmas Decorations</u> The fund currently has over \$2,600. The plan is to purchase six additional snowflakes and a forty foot banner to hang in town. Also, plans are to ask businesses in town to consider hanging the old wreaths that are not being used. The candy canes will be hung without being lit just to add to the decorations.

Additional Public Comments Concern was expressed about a tree limb at the Baldwin and Bluebush road intersection. The tree is not on village property but the limb is hanging over the roadway. Woodchuck will be contacted with possibility of the village paying for the removal of the limb and the home owner paying for the remainder of the tree if he chooses.
