## **Motion to Swear in New Council Member:**

**Motion: T. Lieto 2<sup>nd</sup> D. Shaw** to appoint Tonia Satkowski to fill the remainder of council member Mike Gramlich's term. Roll Call: T. Lieto - Yes, D. Shaw - Yes, B. Iott – Yes,

M. Liedel – Yes, President J. Grubb – Yes. Carried.

Motion to Approve Agenda: Motion B. Iott 2<sup>nd</sup> D. Shaw to accept agenda as presented. Carried.

Motion to Approve August 14<sup>th</sup> Meeting Minutes: Motion D. Shaw 2<sup>nd</sup> T. Satkowski to accept the August 14<sup>th</sup> Meeting Minutes as presented. Carried.

Motion to Approve August 8<sup>th</sup> Garbage Pickup Ordinance Workshop Meeting Minutes: Motion B. Iott 2<sup>nd</sup> D. Shaw to accept the August 8<sup>th</sup> Garbage Pickup Ordinance Workshop Meeting Minutes as presented. Carried.

Motion to Approve payment of the Bills: Motion T. Lieto 2<sup>nd</sup> D. Shaw to approve payment of bills as presented. Carried.

<u>Motion to Approve Treasurer Report:</u> Motion D. Shaw 2<sup>nd</sup> B. Iott to approve the Treasurer Report as presented. Carried.

### **Old Business:**

**Garbage Pick-up Ordinance:** An update was given by Council Member B. Iott and it was suggested to have another workshop with the Village attorney present. It is hoped to have a draft ordinance ready for the October council meeting and implementation by January 2025.

# Hall Rental/Park Rule Policy Updates:

**Motion T. Lieto. 2<sup>nd</sup> B. Iott** to amend the Hall Rental Policy to allow hall rental to non-residents for a fee of \$200 and a returnable \$100 security deposit. Carried.

#### Park Ordinance:

Motion B. Iott 2<sup>nd</sup> D. Shaw to adopt Village of Maybee Ordinance Amendment No. 2024-02. Carried

## **New Business:**

**Council Vacancy (Council Member N. Archer)** Council Member N. Archer turned in his Letter of Resignation effective immediately. A notice will be posted on the Village Website for any resident wishing to apply for the vacant seat.

**Sewer Billing Split:** Treasurer J. Grubb explained recent knowledge of a need to correct a sewer tap over billing for Mr. Kohler's Raisin Street property. Changed from 2.5 taps to 1.

Motion: D. Shaw 2<sup>nd</sup> T. Lieto to adjust Mr. Kohler's sewer tap billing from 2.5 to 1. Carried.

**Line Striping Machine:** President J. Grubb presented the council with the pro's and con's of purchasing equipment so the Village can do their own striping of roads vs contracting the work out.

Motion: D. Shaw 2<sup>nd</sup> T. Lieto to allow for \$3,500 for the purchase of a striping machine and necessary safety supplies. Carried.

**Tennis Court Reconfiguration:** Discussion was held on changing the tennis court at the Village Park to a pickle ball court. President J. Grubb stated that the purchase of the commercial nets needed for the Pickle Ball court would be purchased by the Recreation Committee.

Motion B. Iott 2<sup>nd</sup> T. Satkowski to change the current tennis court into a pickle ball court with the Recreation Committee purchasing the nets. Carried.

### **Sidewalk Repairs:**

Motion: T. Lieto 2<sup>nd</sup> D. Shaw to allow \$1,000 for sidewalk repairs on Kreps Dr. Carried.

**Bluebush Shoulder Widening:** President J. Grubb gave information regarding a quote from JB Seal Coating & Paving for the widening of approximately 1100 ft. of asphalt on Bluebush Rd. from Joseph to Baldwin on one side of the roadway at a cost of \$19,000.

**Public Works – Drains at Large Budget Amendment:** 

Motion B. Iott 2<sup>nd</sup> D. Shaw: to accept the Budget Amendment to the Public Works-Drains at Large account from \$2,000 to \$17,000 to offset the Spring cost of payment for Drain cleaning as presented.

Carried.

**Council Comments:** 

Council Member D. Shaw discussed resident's concerns regarding the Post Office being closed during

normal business hours.

**Public Comments:** 

• Citizen concerns regarding arrows going in only one direction on the Baldwin Rd. bike path

• Resident Sandra Lentner presented a letter to the Council requesting consideration to change the 3-Way Stop Sign at High and Raisin back to a stop sign only at High.

• Discussion of installing electronic locks for Village Hall for security reasons during Hall

rental.

• Discussion of security and safety updates to Village Hall Office area.
