### **Unfinished Business:**

- **Biccum Property Split** – A letter was sent out from the Village of Maybee office to all municipalities involved with the Maybee Library.
- **Hall Construction Update** – President Joel Grubb explained the project plan for the hall and Office. The plan is to add a door from the office area to the hall area and to add an exterior door from the hall to the outside. Construction has started this week.
- **Park Projects Update** – President Joel Grubb explains that the Village has removed the old tennis net and damaged poles. New pickle ball nets will be installed.
- **Recreation Committee Update** – President Joel Grubb announced that kids spring sports sign up form is active on the Village of Maybee website. Also, one of the local churches is interested in using the ball field as their home field.

- **Bike Path Benches** – Donna Boes would like to donate 2 benches in honor of Dorothy Levasseur and Donna Boes' late husband John Boes. **Motion** to approve putting 2 memorial benches in with concrete pads under the benches and hardware to bolt them down in the amount of \$300.00 to be covered by the Village of Maybee, D. Shaw **2<sup>nd</sup>** B. Iott. **Carried.**
